An update from SEND 0-25 following the Government announcement on Monday 11th May 2020

As you may be aware new guidance is being released from the DfE with regard to announcements made by the Prime Minister was released on the 10 and 11th May 2020 and educational settings are beginning preparations for children in particular year groups to return to their mainstream schools and settings, from the 1st June 2020. This is only provisional however and conditional on the basis that the rate of infection remains below 1. Special schools and colleges are not being asked to admit particular year groups from the 1st June, but rather increase pupil numbers over a phased period of time in line with risk assessments that have been completed.

We are currently working with POD's and IASS to create some FAQ's that we hope will help moving forward, in the interim please see the link below to the Government's guidance for parents and carers which was updated.

Children and young people who are vulnerable and / or are children of critical workers who have been eligible to attend throughout the school closure period, should continue to be able to attend their school, college or early years settings as they are currently.

Temporary Changes to legislation due to Coronavirus (Covid 19) Education Health and Care Plans

Over the last few weeks some changes have been made to the 'SEND duties', these have been deemed necessary to help protect the needs of children and young people with SEND and manage the demands on local authorities and health bodies to respond to the Coronavirus outbreak. We would like to share with you a brief explanation about the changes and the link to the Department for Education guidance that the local authority has been following.

Change Number 1

A new exemption to the 20 week Education Health and Care timescale will be permitted due to issues relating to Coronavirus.

This will mean some Education Health and Care assessment requests will not be completed within 20 weeks at this time. This might, for example, be due to professionals being unable to complete their assessment. Where this is the case we will write to parents and settings to let them know. Where it has been necessary to apply an exemption we will also try and catch up as quickly as possible so that the assessment process does not drift.

As far as possible we will still attempt to deliver all assessments within the 20 week timescale. All professionals who give advice have been asked by the Department for Education to use creative ways in which to provide their information so that assessments continue to be made and Education Health and Care plans issued in a timely manner. Determining which EHC assessments will be exempt from the 20 week timescale will be made on a case by case basis.

This change came into effect from the 1st May 2020 and will be in place until the 25th September 2020 in the first instance.

Change Number 2

The duty to secure or arrange special education provision and health care provision in Education Health and Care plans is temporarily modified to a duty to use 'reasonable endeavours' to do so.

Decisions regarding 'reasonable endeavours' must consider what needs to be delivered for a child with an Education Health and Care plan during this period. For the majority this is likely to mean that provision will be different to that which is set out in their Education Health and Care plan for some, or all of the time that the legislative notice is in.

Reasonable endeavour must consider what is necessary for each child. Alternative provision arrangements that are put in place will need to consider local circumstances, this is likely to include discussion with schools, guidance on measures to reduce the transmission of coronavirus, the extent home learning programmes can be made available and the availability of suitable IT equipment in the home.

Example of alternative arrangements may include

- Alterations to the frequency and timing of delivery of provision in school.
- Video class sessions for children to keep in touch with classmates and teaching staff.
- Home learning reading programme, provided by SENCo, reviewed weekly.
- EPs providing therapy interventions.
- SALT/OT input via video link.

(All of these suggestions are taken from the Department for Education guidance).

This change came into effect from the 1st May 2020 and will be in revised on a monthly basis by the Secretary of State.

The majority of provision in children's EHC plans are delivered through educational settings. In Telford and Wrekin we know, because parents have told us, that early years providers, schools and colleges are supporting families to deliver home learning programmes and are 'checking in' with families.

We are aware that SENCos are keeping oversight of children both with an Education Health and Care plan and at SEN support to make sure home learning is accessible. We have heard about virtual interventions (reading and phonic based programmes) that are taking place. We know that some part time provision has been deemed appropriate. All of these activities help us to deliver on the 'reasonable endeavour' duty. In Telford we also have a range of educational support services including Portage, Sensory Inclusion, Learning Support Advisory Teachers, Behaviour Support and Educational Psychology that support settings.

All other duties within SEND legislation remain in place namely:

Annual reviews of children's EHC plans require completion—there is acknowledgement that reviews may be briefer and held in a different form such as a virtual meeting.

Educational settings must continue to admit children once they are named on an EHC plan—this means a setting must put the child on roll and treat the child in the same way as all other children are being treated at the setting at this time.

Settings must respond within 15 days of the LA consulting with them regarding proposals to name them in a plan.

The SEND appeal system remains in place. There are no new complaints processes for the temporary legislative duties and where disagreements arise local dispute processes should be follow.

Duties in law over EHC needs assessments and plans have not been 'turned off'. In Telford and Wrekin where new requests are being considered, either by an educational setting or parent, please discuss these first with the SEND team before starting an application. They will work with you and your child's setting to discuss how best to get support and provision in place for children which might involve the use of more flexible release of funding through the <u>Early</u> Years Inclusion Funding or Inclusive School Forum!


