**Reach out** to local press to let them know how you are celebrating Safer Internet Day.




**Customise** our Safer Internet Day social media template and share what your learners create. What do the young people you work with feel they can do to create **#AnInternetWeTrust**? What do they think others can do – social media and gaming companies, government, teachers or their classmates? Use the template to explore how we can all work together to question the online world and **challenge** ourselves and the people and apps we interact with online to **change** the internet for the better.

They could fill the magnifying glass with their ideas about how we can create **#AnInternetWeTrust**. This could be:

- Questions to ask when you are looking at information online, for example: Who wrote this? Why was it written?
- Words or questions we can ask to help us spot if something is reliable online.
- Illustrations of what a better, more trustworthy internet could look like. Or images of online clues that may make something seem less reliable or trustworthy.
- Pledges of what they will do to help create a more trustworthy internet, such as, "I will only share things I have checked are true" or "I will support my friends if fake news upsets them."
- They can also fill in the #AnInternetWeTrust hashtag template in any way they like!

Take a photo of the decorated templates (with learners and educators too!) and share on your organisation's or school's social media accounts with the hashtags **#AnInternetWeTrust** and **#SaferInternetDay**, as well as tagging **@UK\_SIC**. We would also love to see how you have used the templates to create a display in your setting!









## Important note about sharing on social media:

When sharing your school/organisation's Safer Internet Day activities, including any social media templates decorated by children and young people, please only use your official school/organisation accounts. Do not ask children and young people to share via their personal accounts.

Please ensure that you have the appropriate media consent from parents or carers of any children and young people appearing in any images your school/organisation shares online.

Any photos shared online using the #SaferInternetDay or #AnInternetWeTrust hashtags and tagged @UK\_SIC may be reshared by the UK Safer Internet Centre's official social media channels. Only photos sent from official school/organisation accounts will be reshared.
